In Memory of Mary Ellen Lewis

We are saddened to report that Mary Ellen Lewis of Aurora, Colorado, passed away May 13 at the age of 87 years. Those who knew her loved her energy and commitment to BPW Colorado and BPW Aurora. She ran the BPW Colorado Celebration of Women program for many, many years, and we will be eternally grateful for her.

### Mary Ellen's Life and Personal Story

Mary Ellen Lewis was a Denver native born August 17, 1935. She was the youngest child of Kenneth and Ella Lewis. She was preceded in death by her siblings

Charlotte Elkins, Kenneth K. Lewis, and Sister Mary Kenneth, a/k/a Shirley.

Mary Ellen graduated in 1959 from the University of Denver with a B.S., and in 1985 received a Master's degree from the University of Colorado Denver.

In 1961 Mary Ellen signed on with the U.S. State Department and was assigned service in Thailand, Laos, Cambodia, and Pakistan. Her love of elephants was born while overseas.

In 1966 Mary Ellen was hired by the University of Colorado Denver as a business administrator. She later became part of the faculty and an advocate for women in the business world. She was an active member of Business and Professional Women of Colorado. She mentored women and men about how to succeed in the competitive business world. While at DU, Mary Ellen became an active member of Phi Chi Theta. She served as chapter president and then multiple national leadership positions. Recently she was Treasurer of the Phi Chi Theta Foundation. She worked to provide scholarships for business students in colleges throughout the U.S. Phi Chi Theta has rewarded her years of service with the Lewis Foundation Scholarship to encourage generations of future business students.

She retired in 1997 and enjoyed life as a nanny. She volunteered at Denver Hospice. Mary Ellen had season tickets for the CU Buffaloes and Denver Broncos. She braved the elements to attend each game, including Bowl games, looking every bit the fan! She earned travel with Frontier Airlines. She was always on the go!

As a devoted Days of Our Lives enthusiast, she cruised the oceans with the cast for about 10 years, getting to know them individually and their families. She often wrote letters suggesting a new story line. Her cruises were the highlight of every Christmas letter.

Mary Ellen continued to keep in touch with all her school chums attending regular events with the St. Francis alumni, the DU alumni, and the CU alumni. She was part of the Aurora Women's Club monthly meetings. Mary is remembered as a true friend, humble and kind. She was determined to make a difference with her life. She succeeded! We at Business and Professional Women will miss her very much!

### ERA Centennial Convention in Seneca Falls, NY

**Purpose**: The ERA Centennial Convention seeks to mark the important historic milestone of the ERA Centennial, celebrate the women and queer people who have fought for the ERA for 100 years, push for finalizing the federal ERA, and launch the grassroots fight for a New York state-level ERA ballot initiative. The goal is to mark the century-long fight to get the ERA into the Constitution by ending it.

**Objective**: The objective of the ERA Centennial Convention is to hold an intergenerational convening on July 21-22, 2023 in Seneca Falls, NY at the <u>First Presbyterian Church of Seneca Falls</u> where the National Woman's Party first unveiled the ERA – at the exact same podium Alice Paul gave her speech that day, 100 years ago. The event will be focused on cultivating the next generation of ERA activists and helping them see their place in history as constitution makers. The target will be to have at least one ERA activist from all 50 states attend the in-person event to build a nationwide network of advocates, and set goals for constitutional equality for the next year.

The Convention will be action-oriented. We will ground ourselves in a critical examination of the past in order to make choices for the future that will help create a more diverse, inclusive, effective ERA movement going forward.

A major focus for this year will be various organizations around the country or even the world that help, support and advocate for the LGBTQ+ community. Because of the impact these laws have and the inequality faced, going forward, this section of the LGBTQ+ advocacy column will be devoted to highlighting those bills and bring awareness to just what kind of situation the transgender community especially is facing. There will also be good news as well to share because there always needs to be a silver-lining among the clouds.

Signed on April 28th, Senate Bill 99 blocks transgender and nonbinary minors from receiving medically necessary care including hormone replacement therapy and puberty blockers. Governor Gianforte was lobbied by his nonbinary son, David Gianforte, who had called on his father to veto the bill.

After she spent days fighting against a bill that would ban gender-affirming care and her right to speak on the floor of the Montana state legislature, state Representative Zooey Zephyr was censured yesterday [April 25, 2023] afternoon. Earlier in the week, protests had erupted in the chamber as the Montana House debated yet another draconian anti-trans bill. As the first out trans person elected to the state legislature and representative to 11,000 Montanans, censuring Zooey is wildly undemocratic.

Senate Bill 613, which prohibits best practice medically necessary care for Oklahomans until the age of 18 was signed by Governor Stitt on May 1st.

The legislation calls for the death penalty for particular same-sex acts, and bars promoting LGBTQ+ causes or identities which is punishable with a 20-year prison sentence. President Yoweri Museveni had previously returned the legislation to parliament and will likely sign the bill into law.




Change is happening all around us. In our personal lives, our professional lives and in our volunteer organization. The following article is from Focal Point powered by Brian Tracy, and it speaks not just to the inevitability of change, but also how to change. It is my hope we can all work together to embrace change. – Sondra Nunez

The challenge of change affects Businesses every day, every month, every year. Once could argue the single most important factor affecting the health and longevity of Business is effectively addressing change.

The rate of which change happens is not an option. Successful business owners, Leaders and Executives are those who have developed the ability to operate confidently / successfully in a world of rapid change. There is method, technique, and strategies to deal with Change in your Business that you cannot slow down or sometimes predict. Learning the Seven R's for change and how you can identify where these principles can be applied will give you a greater sense of control, confidence and success in your business.

First there are three major factors driving change: Knowledge, Technology and Competition. Knowledge and Technology is moving at light speed. Remember Video rental stores? How about Border's bookstore or better yet at one time Sears Roebuck was the number 1 company in the world. The rate of change in those industries in Knowledge and Technology along with those companies' lack of addressing those when they were identified lead them to the end as quoted by Mr. Jack Welch.

What other areas today are in Knowledge, Technology and Competition rapidly changing? Taxi's? Landline Telephones? Television programs?



A successful business owner, leader or executive needs to identify changes as soon as possible, then have Openness, Willingness and Adaptability to the change. Clarity, Zero–Based thinking and understanding your constraints are all baseline for you to succeed in addressing change. As promised here is a methodology of Seven R's to get you started:

- 1. **Reorganization** requires you to find ways to increase outputs relative to inputs. Look at everything your business does for efficiency and effectiveness.
- 2. **Restructuring** means you move people, money and resources constantly to the activities that customers most value.
- 3. **Reengineering** involves looking for ways to do things under the thought of: "Time compression by responsibility expansion". How can you do more or different?
- 4. **Reinventing** means taking a step back, looking at your business. What you know now, what would you do differently?
- 5. **Reevaluating** is the step where you annually or twice year imagine starting your business over. How would you do what you do different? Should you?
- 6. **Rethinking** is the hardest of all the Seven R's. This requires you to abandon your assumptions and look at your business with a new set of eyes and Mind.

7. **Refocusing** – The final step in the Seven R's. Time to act. Make the commitment to re-focus you and start to drive your business before change drives you.

Sometimes Business Owners, Leaders and Executives get in a rut because business is good. Even Small Business owners need to address these issues. A great strategy is to bring in someone to help you with ensuring your "rate of change inside exceeds the rate of change outside."

### Simple Acts: Educate Yourself About Water

Are we running out of clean water? Despite water covering 71% of the planet's surface, more than half the world's population endures extreme water scarcity for at least one month a year. Current estimates predict that by 2040, up to 20 more countries could be experiencing water shortages. These statistics raise a raise a startling question: is **the Earth running out of clean water?** Toxic **"forever chemicals" known as PFAS** are polluting drinking water sources, including groundwater, of at least 200 million people in 38 states & Puerto Rico. These per-and-poly-fluoroalkyl, PFAS, chemicals are found in products like food packing, nonstick pans, carpets, waterproof mascaras, sunscreen, shampoos, waterproof jackets, firefighting foams. PFAS don't break down easily, persisting in our environment for decades. According to the CDC (Centers for Disease Control & Prevention), "more than 97% of the U.S. population has PFAS in their bodies." <u>https://tinyurl.com/2p9f852s</u>




PFAS & replacement chemicals, such as GenX, cause dangerous health problemskidney and testicular cancer, endocrine disruption, & immune system suppression.

The Clean Water Act, enacted by Congress in 1972, when rivers were actually on fire due to polluting corporate industries, protects our waterways & wetlands, ecosystems that provide food, prevent flooding, & are critical to wildlife. Unfortunately, а political battle ensuing over the past two decades has tried to undermine the overwhelmingly

## Bring Back the Pollinators by Marikay Shellman

Don't spray your roses or lilacs when you see these circular marks! These are made by beneficial insects, Leaf cutting bees (Megachilidae) and your plants are not damaged. They are solitary bees, not living in colonies, are non-aggressive and indispensable for pollination of wildflowers, fruits, and vegetablesalfalfa, blueberries, sunflowers, peas, cosmos, blackeyed susan, and dahlias to name a few.



These black bees, about the size of a honeybee, emerge in Spring & mate. The females build nests in wood cavities, rotten wood, hollow stems, empty snail shells, dry soil, and holes in concrete walls. Then she chews <sup>1</sup>/<sub>4</sub>' to <sup>1</sup>/<sub>2</sub>" circular pieces from flower petals and soft flexible leaves of roses, lilacs, redbud trees, hostas. The leaf cutter bee then lays these pieces into a shape of thimble for each cell. Each nest consists of 20 cells packed tightly together similar to mason bees (same family). Next, she collects nectar which she mixes with her saliva & creates food for her larvae. Placing this



food into each cell, she lays a single egg in each cell & seals cell with chewed leaves. Leafcutter bees take only leaves they need for constructing nest When larvae emerge, they feed on food in nest & pupate over winter. In the spring, they chew their way out of their nest and emerge as adults.

Because leafcutter bees are such efficient pollinators, they are considered to be beneficial insects as opposed to insect pests. Using insecticides will kill beneficial insects- the ones you need in your garden.

## If it Has a Recycle Symbol is it Really Recyclable?

Just because a product has a recycle symbol does not mean its recyclable. The different numbers indicate different types of plastics that are recycled differently. Generally plastics 1,2,5 are recyclable but not 3,4 and 6.

Several years ago someone offered me coffee in a doctor's office in a Styrofoam cup which has a number 6 symbol on it. I declined saying that Styrofoam is not recyclable. He argued saying, "Well if it's got a recycle symbol on it I'm throwing it in the recycle!"

When I got home, I sent him an email with a couple of links to articles about Styrofoam and how bad it is for the planet. He wrote back thanking me saying he was glad to learn something new.

The whole labeling system is broken, and companies need to be held responsible for correct labeling. There is a lot of "Greenwashing" out there. Greenwashing is deceitful marketing that exaggerates a business's current or past practices in order for them to appear more environmentally friendly.

I intend to find legislators this year who might introduce a bill regarding this huge problem. The plastics that are not recyclable never really go "away" and so much plastic ends up in our environment and oceans! Please reduce your single-use plastics.

The BPW Colorado Annual Convention will be held on Saturday, June 17. The Business

Meeting will take place in the morning via Zoom. In the afternoon there will be a social event in person, at which we will install the new officers, hear from various notable BPW and community members, and enjoy the opportunity to network with one another after a few long years with little opportunity to see one another in person. <u>Click Here</u> to register.

One of the key activities at the Business Meeting of Annual Convention is the election of officers. All 5 officer positions are up for election this year, and the Nominations Committee will present a slate (we are happy to report that most or all of the current officers will run for re-election). We will also be looking for volunteers to serve as committee chairs. The other key item of business is approving our budget for the next year.

BPW Colorado's Advocacy Committee is done with its work for the year, because the General Assembly adjourned on May 8. BPW Colorado took positions on 88 bills, most of which passed or were defeated in alignment with our positions. We had 3 high-priority bills we did our own advocacy for and which have passed. The first one (SB 189) has already been signed into law, and the other two have been sent to the Governor to sign – but he has until June 8 to sign or veto them, and we won't rest easy until they are signed:

- > Senate Bill 105, Ensure Equal Pay for Equal Work
- > Senate Bill 172, Protecting Opportunities & Workers Rights (POWR)
- > Senate Bill 189, Increasing Access to Reproductive Health Care

The major topics of other bills we are following are:

- Accessible and affordable housing
- Gun safety and violence prevention
- Environmental protection and sustainability
- Equal economic opportunity
- Protection from discrimination and abuse
- Safeguarding reproductive choice and health care

Everyone that has had an anxiety or panic attack knows that there are short term solutions to help get your head back in the game. As for more advanced mental issues, there is short term and long-term help. But most important, there is no shame in taking care of you. I am not a medical professional nor do I play one on TV but, I have had to take care of me emotionally and mentally after some challenges in my life.



Now, "Can I Get A Relay?" In Eastern North Carolina (Edgecombe County) we are gearing up for Relay for Life. I got involved in this while working at Carolina Telephone a.k.a Sprint. I was a member of the Community Relations Team (C.R.T.) We supported events in the community, and one was Relay for Life. Once I got involved, I have been involved ever since. I wanted to help find a cure for cancer by raising funds for research.

We all know someone who has had cancer and died, but we all know someone who has had cancer and lived. I want to share my two friends Bree and Dee's story. (Not their real names).

Bree and I have known each other ever since first grade. When Bree found out she had breast cancer, she was shocked but not distraught. She had a great support system. She knew people that had cancer and survived. She was told they found it early so she had a good chance they would get the whole thing and she would survive. She was also top heavy. She did not care about reconstructive surgery, just get the cancer. They did and she is still here supporting family and friends. She and her husband are enjoying the grand kids. One note, when you visit Bree, she may have a prothesis on or not. If she is comfortable, you may as well be comfortable. But when it is time to dress up, both "girls" are in place.

Now Dee, I met her in the 9<sup>th</sup> grade. When she found out she had cancer, she called me and wanted to come to the house to talk. I had no clue what she wanted to tell me.

I noticed she was not her usual talkative self. So, she blurted it out that she had breast cancer. I was like, "Oh my goodness." That is the second friend. She was so down, and we named all the people we knew who had cancer. But I noticed we were naming all the ones that had died.

I stopped and said, "Wait a minute, what about this person, and this person and so on? She looked and said, "Yeah right and this person and on and on." The power of positive thinking. (There's that mental health again.)

Well, Dee had the surgery. Dee was also top heavy. They told her they could build the breast up like the heathy one. She said, "Are you crazy? Bring them down to a smaller size. I can get breast reduction, let's do it. "That's taking a bad situation and making a positive one." She and her husband are doing wonderful and enjoying their grand kids.

After seeing my friends go through all that, I knew I wanted to help fight cancer. So, every year, if I am not a team captain, I am on the county leadership team or both.

One year I suggested we have a blood drive at Relay. We did. It was quite successful. (As you know, when you have surgery, you need blood.) That was the same day "Ronald McDonald" made a visit. He came to our blood mobile. I had a big grin all over my face. Our local Relay gives a survivor banquet during Relay, and we make sure all the survivors get a survivor T-shirt.

Now you see why I relay. Having cancer is not an automatic death sentence anymore. So, ladies, do your breast exams, get your annual mammograms, and look for any unusual lumps or bumps. They may be something simple, but it is best to be sure. Again, I am not a doctor or nurse, just a concerned BPW woman. You know "Women Helping Women."

## The Accident by Marsha Riibner-Cady

Many of you know that my husband, Lyle, and I spend part of our time in NC and the other part in WV. It's a 7-hour drive between the 2 places. We travel with our Rotties, Astoria and Indie. They travel in big dog crates in our 2015 Toyota Sienna van, which typically leaves not much room to transport anything but us and the dogs. I am famous for stuffing 10 pounds of potatoes in a 5-pound sack, so you would be amazed with what I can make fit in a space that is 4 ft x1 ft x 3 feet...



On Monday, May 22 we were ahead of schedule, and it looked like we would arrive in NC while it was still daylight. That never happens because if the packing of the car to wedge everything in just right.

There we are, eastbound on US 66 near Marshall, VA and I'm driving Lyle's van. Someone creeps over in my lane at 70 miles an hour, where am I going to go? Well, I aimed for the shoulder, but ended up in the ditch and then riding the guard rail. WE ARE ALL OK, INCLUDING THE DOGS. It was a bit harrowing getting the van off the guardrail and back on the shoulder. As you can see from the pictures, it's quite a mess.

I have also wrecked Lyle's 300E Mercedes in Natural Bridge, VA. I turned into someone. We all survived that one, too! It did involve moving everyone around in a corvette, another story for another day...

So, I get the car stopped which woke up my napping husband in the passenger seat. Now what? It's not drivable.

I call 911. Keep in mind it's National EMS week and luckily, we don't need medical attention, neither do our 90 pound 4 legged friends. We do need help. As luck would have it, the safety patrol stops and makes sure traffic stays out of the lane closest to us and they also put out those big orange barrels near the now non-existent guard rail.

The state police are on the way, so I decide to call AAA. The last time I called them, it took 5 hours for a tow. That involved my Nissan Versa and a bunch of black smoke, again another story for another day. So, I'm not looking forward to sitting on the side of the road with the dogs or Lyle who's handling his banged-up van well.

The officer arrives. I tell him my story, finally locate the registration, insurance card and my license. What a mess that glove box was, Lyle must have had 10 years' worth of registrations and insurance cards. Does he not throw anything away? Never mind we all know the answer to that one.

Luckily at this point in my life I have a clean driving record. In the past I had a bit of a led foot. There was that side swipe accident back in the late 80's and the bridge I hit. To be fair, there was ice on the road for the bridge incident.

The good news is that I'm not being charged for reckless driving and since the damage was only on our car, there won't be any tickets. The state may charge our insurance for the guard rail repairs. How much are those?

The officer insists on calling a tow truck for us as mentioned above, the last time I waited for AAA, it was 5 hours. He confirms that unless he calls for a tow, it could be that long again. 15 minutes later, the tow truck arrives. The driver is nice, he also happens to be our AAA driver, which didn't become apparent until later in the conversation. The dogs ride unsupervised in the van while we are in the cab with the driver. Again, remember they are in crates. Bottom line, we end up with our stuff in a "storage yard" somewhere in near Marshall, VA. Did I mention the dog crates? Yes, the dogs are sitting in them in the middle of the junkyard.

Mike to the rescue. Lyle's daughters' husband Mike is on the way with another van. Thank heavens for Mike. He's a plastics engineer. Not great at packing a van, but a good guy none the less.

So now the insurance company. It's State Farm. They were helpful in getting me through the paperwork and the app is amazing.

Now we wait, to total or not to total, that is the question!

A few takeaways from this incident...

Texting and driving may not hurt you, but it could hurt someone near you.

Rental car and towing should be on everyone's insurance policy. Lyle only had towing. The rental van will probably cost \$1000 for the week. Rental car on your insurance policy is \$10-15/6 months. I asked after the fact. I have rental car insurance on my Nissan Versa, just saying...

The officer was kind enough to say, "I mean no offense to someone older than me, but maybe you should put the important papers in an envelope with the name of an emergency contact, just in case you both have to be airlifted out." The older than me thing really got to me as I was always the youngest in the group. Not any longer, I guess. He did have a good point about the emergency stuff, you know.

Be sure your dogs are safe and secure while being transported. Dog crates are great. Could you imagine having 2 big dogs flying around the van? What if we would have rolled?



In retrospect who leaves 2 old people and 2 dogs in a junkyard and drives off? I mean the tow truck driver was nice up to that point, but what would we have done if Mike wasn't able to get us a rental van? We were told we could call an uber. We were in the middle of nowhere. Did I mention 2 big dogs? And we even tipped the guy. We are idiots sometimes...

Even stepson in-laws can be helpful. Mike really is a good guy. I guess "blood" is thicker than water. He did forget to take his car charger out of the rental van, so I mailed it to him today with a nice note. It's always good to be polite.

WE ARE OK, which is the biggest blessing of all. There was literally a drop off 100 feet on the other side of that guardrail.

The van had 130,000 miles on it. We were hoping to get a few more years out of it. Have you seen car prices? Maybe I can teach the dogs to pull a cart? I'm thinking that would make the drive much longer than 7 hours.

Again, WE are all OK. It wasn't our time, we still have some of our 9 lives left, the God's were on our side. Fate, Karma? No joking aside, you never know when this will be your last day. Live every day to its fullest. Be well my friends and be safe out there. Marsha

### SENATE BLOCKS S.J. Res.4 -- REVIVED EFFORT TO PASS E.R.A.:

A procedural vote of 60 Senators is required to bring a Resolution like S.J.Res.4 to the floor for a vote. On 4/27/23 by a vote of 51-47, S.J. Res.4 to enshrine the Equal Rights Amendment in the Constitution, failed to advance. Only two Republican Senators supported S.J.Res.4, Alaska Senator Lisa Murkowski and Maine Senator Susan Collins. The Equal Rights Amendment was first introduced <u>100 years ago in 1923</u>. In a statement the 102 year old League of Women Voters declared, this failure is "a disappointing day for America." League CEO Virginia Kase Solomon said, "Our nation's elected leaders have failed yet again to see us as equal members of this democracy. Inequality hurts everyone, and we must not continue to be a nation that harmfully excludes and marginalizes women." Following this vote the Senate recommitted the E.R.A. Resolution to revisit it at a future date.

### FIRST WOMAN CONFIRMED ARCHIVIST OF THE UNITED STATES:

On 5/11/23 the Washington Post reported U.S. Senate confirmation of Colleen J. Shogan, a former senior Library of Congress and White House Historical Association official, as the 11<sup>th</sup> Archivist of the United States, the first woman to head the National Archives. She succeeds David S. Ferriero who retired in April 2022. Shogan, 47, was nominated by President Biden last year. Prior to retiring Ferriero signaled the White House, "Better not hire another White male. We've had 10 White males." Shogan stated her nomination was "the honor of a lifetime." "My passion for the American story started in the public high school I attended outside Pittsburgh. As a first-generation college student in my family, I was fortunate to receive a first-class education which allowed me to explore the development and evolution of American ideas and institutions."

### GOLDMAN SACH'S SETTLES GENDER DISCRIMINATION SUIT FOR \$215 MILLION!

It only took 13 years and a trial date set in June for Goldman Sachs to finally agree to a gender discrimination lawsuit affecting 2,800 women employees. The women worked as associate or U.S. vice presidents in investment banking, investment management or securities divisions. Filed in September 2010, the lawsuit claimed the bank discriminated against women in pay, performance evaluations and promotions. Aside from the payment, the settlement includes a three-year period during which Goldman will work with an independent expert to reassess its performance evaluation process, as well as its processes for promoting individuals from Vice President to Managing Director. It also requires an independent expert to conduct additional pay equity studies and for the New York-based company to investigate and address any gender pay gaps where appropriate. The bank set targets in 2020 to recruit more diverse talent, aiming for 40% of women vice presidents by 2025.

In her book, "Bully Market," former Managing Director Jamie Fiore Higgins recounted the sexism she endured at Goldman Sachs including colleagues mooing at her when she left to pump breast milk. She also alleged a male employee assaulted her, pinning her neck to a wall. The long-standing class action lawsuit alleged the finance giant systematically underpays and undervalues women. A similar 2007 lawsuit against Morgan Stanley by six women, also alleged gender discrimination. It was settled for \$46 million. That suit was later expanded to cover a class of around 3,000 women who worked at Morgan Stanley between August 2003 and June 2007. In

2013 Merrill Lynch paid \$160 million to Black financial advisers to settle a racial bias suit. In 2017 Wells Fargo settled a class action accusing the firm of racial discrimination for \$35.5 million. According to reporting by CBS, Reuters and the Los Angeles Times, had the Goldman case gone to trial in June, it would have laid bare for the public a rare look into gender dynamics that underpin high-profile Wall Street firms' operations. Although roughly 45% of finance sector employees are women, just 15% hold executive roles, according to data from the World Economic Forum's 2017 Global Gender Gap report.

### FEWER WOMEN CHIEF U.S. ECONOMISTS AT TOP FINANCIAL INSTITUTIONS:

Bloomberg Businessweek's 5/8/23 issue reported that "Chief US economists who are women have gotten even rarer at top financial institutions." Only Morgan Stanley currently has a woman, Ellen Zentner, in the job. Among the almost two dozen financial institutions that are designated by the Federal Reserve as primary dealers and that employ a Chief US Economist or equivalent, Zentner is the only woman. Eighteen months ago, at least three women held such roles. They help the Fed implement monetary policy. Issues including bias and balancing family with the job's grueling travel schedule are reasons for the gender disparity in a narrowing pipeline of women aspiring to be a chief economist. The result is a shortfall in a position crucial to setting market expectations. Preparing key economic reports, steering discourse on subjects like inflation and the labor market, and ultimately shaping investors' and the public's views on the U.S. economy's path, is lacking women's input. With almost two decades at Citigroup Inc., Conference Board Chief Economist Dana Paterson, said, "You need different perspectives. You need different lived experiences. You really need to understand what's going on in the full population, and I think having women in these roles helps bring to light different aspects."

According to Businessweek, women with advanced degrees in economics often choose concentrations such as labor markets and education rather than macroeconomics and finance. Diane Swonk, Chief Economist at KPMG LLP, spoke of challenges being treated differently by colleagues or clients. "When I would show up to do a speech with a banker, they would ask me if I was there to take notes," referring to experiences earlier in her career. Lack of flexibility in reliable child care can be very challenging for women along with discrimination and harassment. An American Economic Association survey of current and former members published in 2019, found almost half of women respondents said they'd been discriminated against or treated unfairly based on their sex. Only 4% of men said the same, though a third of male respondents said they'd witnessed discrimination against others based on their sex. "Knowing what some of the younger women that I know have had to deal with," Swonk said, "it sends chills down my spine that it hasn't changed more." On 5/1/23 Senator Elizabeth Warren (D/MA) introduced S.1393, a bill to require public disclosure of payments for settlements of disputes regarding sexual abuse and certain types of harassment and discrimination. S.1393, the <u>Sunlight in Workplace Harassment Act of 2023</u> was referred to the Banking, Housing & Urban Affairs Committee, according to Women's Congressional Policy Institute 5/8/23 Update.

#### NEW SUPREME COURT ACCOUNTABILITY CAMPAIGN LAUNCHES:

A group of over 30 advocacy organizations announced the launch of the JUST MAJORITY campaign to promote a "fair and ethical" Supreme Court. The Hill reported on 5/15/23 that Alexis McGill Johnson, president and CEO of Planned Parenthood, called for the expansion of the Supreme Court bench amid ongoing revelations of ethics issues surrounding certain justices. Recent attacks "on our democratic rights and our democratic freedom," McGill Johnson said, underscore the need for reforms. "The reality is, the Court now has been fully captured in so many areas." The fact that you have again, this lone Texas judge that can bring cases, you can judge shop, or bring cases to the Fifth Circuit which is also conservative and up to the Supreme Court now, which has a conservative super majority, strains credibility. She criticized the federal Texas judge who ruled in favor of taking a popular abortion drug off the market. It is time for the Supreme Court to expand the bench and implement term limits for justices, the coalition stressed. Ethical requirements are needed. Decisions are being made by "people with lifetime appointments that are very much out of step with where the majority of people are on a variety of issues," McGill Johnson reiterated. The JUST MAJORITY group encompasses advocacy organizations that include March for Our Lives Action Fund, Greenpeace USA, NARAL Pro-Choice America and the Color of Change. Their press release followed revelations of alleged misconduct by Justice Clarence Thomas. The project will spotlight the crisis of legitimacy faced by the Court, the justices' unethical behavior and partisan rulings. In addition to calls for Thomas to resign, momentum is growing for a Congressional investigation and a revamped ethical code for justices. "An unaccountable unethical majority of the Supreme Court is behaving as if the rules don't apply to them," the groups said.

### GROWING SHORTAGE OF OBSTETRICIAN-GYNECOLOGISTS IN TRAINING:

A new survey of medical students released at the Mid-May annual meeting of the American College of Obstetricians & Gynecologists revealed an important impact of the Supreme Court's Dobbs decision on the U.S. medical community. According to a 5/19/23 NBC News report, more than three-quarters (76.9%) of 494 medical students surveyed in 32 states say access to abortion care will influence where they would pursue their residency. After graduating from medical school there is a clear resistance by young doctors to train in hospitals or clinics in states with abortion bans. Health care shortages in many parts of the country will be further strained. Future OB-GYN and doctors who plan to enter other specialties such as surgery and internal medicine (57.9%), were unlikely or very unlikely to apply to a single residency program in a state with abortion restrictions, the survey found. The United States is already facing a major shortage of between 37,800 and 124,000 doctors in coming years, according to the American Association of Medical Colleges (AAMC). Most concerning for women's health, separate AAMC data found a significant drop in the number of medical students pursuing OB-GYN residences in states with strong abortion restrictions, where maternal and infant mortality rates are already higher. Other recent surveys of high school students across the country reveal a significant number of graduates considering state abortion restrictions when selecting college and university locations before applying.
